IÉ CONTRACTOR PTS TERMS & CONDITIONS

1. IE Contractor P.T.S. training is a one day training programme - Registration Time 09.00
2. Nominees must be employed by a company contracted to work for or on behalf of Iarnród Éireann
3. A course fee of €200 per person is applicable (reviewed yearly)- A Purchase Order (PO) or Remittance Notification must accompany this form
4. Passport quality photograph per attendee (signed by applicant and Examining Doctor, where required)
5. Each attendee must be passed medically fit to a standard specified by the Iarnród Éireann Chief Medical Officer. IE Medical Form is the only acceptable format.
6. Employing companies who fail to provide payment, photographs, Medical Report (where required) will result in non-admittance to the course for the applicant(s)
7. As an employing company, if you are paying for a sub-contractor to attend training include a cover letter stating that you are making payment for the specified sub-contractor.
8. Cancellations are only accepted in writing up to 48 hours prior to the confirmed training date, after which full course fee will apply
9. Where participants do not show for training, full course fee will apply
10. Participants must have a good working knowledge of English
11. Participants must partake in an end of course written assessment. On successful completion of the IE Contractor P.T.S. Training Course, participants will be registered with Iarnród Éireann and issued with a IE Contractor PTS Certificate
12. IE Contractor PTS Certificate can be valid for a maximum period of up to 3 years, after which the holder must attend and successfully complete a refresher programme
13. IE Contractor PTS Certificate (where lost) can be re-issued at a cost of €25
14. IE Contractor PTS Certificate remain the property of Iarnród Éireann and can be withdrawn for non-compliance
15. IE Contractor PTS Certificate will be issued within 10 working days once training course is successfully completed
16. The employing company must bear all other costs associated with attending IE Contractor P.T.S. training (employee time and travel, etc.)
17. Neat dress is expected while attending training
18. Each nominee must have a High Visibility Vest (Orange colour) and Safety Footwear on the training course. These are NOT supplied by Iarnród Éireann.
19. IE Training programmes are subject to the IE Alcohol & Drug policy where random testing may be carried out.

- Attachments must be in a PDF format, the attachments must be named to comply with the following format:
 - **PTS Application (Company Name)** – all pages scanned as a single document
 - **PTS Medical (Applicant Name & Company Name)** - all pages scanned as a single document per applicant
 - The front & back of photographs must be scanned
- Remittance
 - Include a Purchase Order Number (PO)
 - If not supplying a PO Number include remittance notification (ensure to include your Customer Number/ Invoice Number in the information field when making payment)

REMOTE TRAINING – TECHNICAL REQUIREMENTS

During Covid 19 a REMOTE version of the IÉ Contractor PTS training course is now available, we utilise MICROSOFT TEAMS to host this training. Each week we have a limited number of places available and applications can be submitted through the normal channels for validation.

If there is an urgency to your requirement for training it is advised that your point of contact/ project manager from Iarnród Éireann presents a business case to the Training Centre outlining the nature of this training requirement. Available places will be assigned strictly according to business need, on a case by case basis. We will always endeavour to facilitate all training requests as quickly as possible.

Iarnród Éireann understands that nominees will have varying degrees of technical experience and ability. Due to the key role technology plays in REMOTE learning nominees must be able to engage with relevant technologies to a minimum level. It is expected that nominees should have minimum computer skills. Nominees should be familiar with using email and browsing the internet.

INTERNET CONNECTION:

Each nominee will need access to a computer with an internet connection. High speed broadband access (LAN, Cable or DSL) is highly recommended for the optimal learning experience.

Web Browser: Internet Explorer 11, Microsoft Edge or Google Chrome (latest version)

Compatible Operating System: OS X
